Estimate your individual accreditation fee in only 2 steps!

STEP 1: Select the accreditation program for your organization by confirming that you satisfy the program's prerequisites

1. Quality in Eye Care

Prerequisites for Quality in Eye Care accreditation:

Conduct business as a **licensed** healthcare provider in your country for at least one completed financial year.

□ Manage ophthalmology and non-clinical services with a **Continuous Quality Improvement** system.

□ Your organization's practices are in accordance with **international standards of medical ethics**, as stated in the World Medical Association (WMA) International Code of Medical Ethics.

If you have ticked all 3 boxes, you are eligible to apply for "Quality in Eye Care" accreditation. If not, please contact us to review your options.

2. Excellence in International Eye Care

Prerequisites for Excellence in International Eye Care accreditation:

Conduct business as a licensed healthcare provider in your country for at least one completed financial year.

Anage eye care and non-clinical services with a **Continuous Quality Improvement** system.

□ Your "International Patient Department" offers comprehensive services including: pre-travel, on arrival, inpatient treatment, discharge, and post-treatment follow-up.

□ Manage international patients for at least two years.

Assure 24/7 access to multilingual staff (or interpreters) for patients and relatives.

At least **10** % **of your patients are regional** (travel within the country or cross nearby borders to receive treatment) **and/or international patients**.

□ Your organization's practices are in accordance with **international standards of medical ethics**, as stated in the World Medical Association (WMA) International Code of Medical Ethics.

If you have ticked all 7 boxes, you are eligible to apply for "Excellence in International Eye Care". If not, please contact us to review your options.
