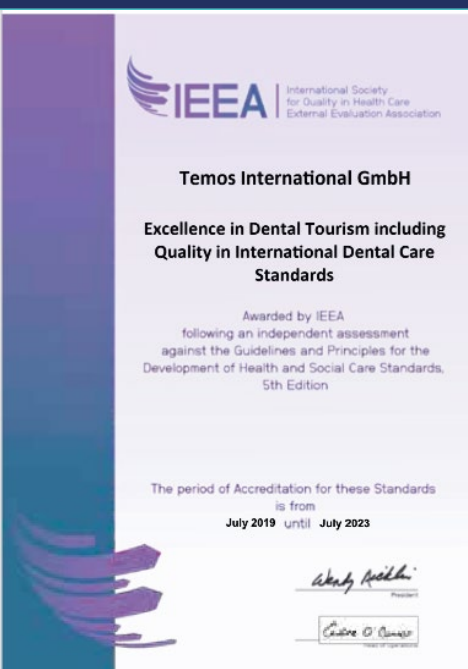

In July 2021 Dr. Mika has been appointed as associate editor of The Journal of Healthcare Management Standards.



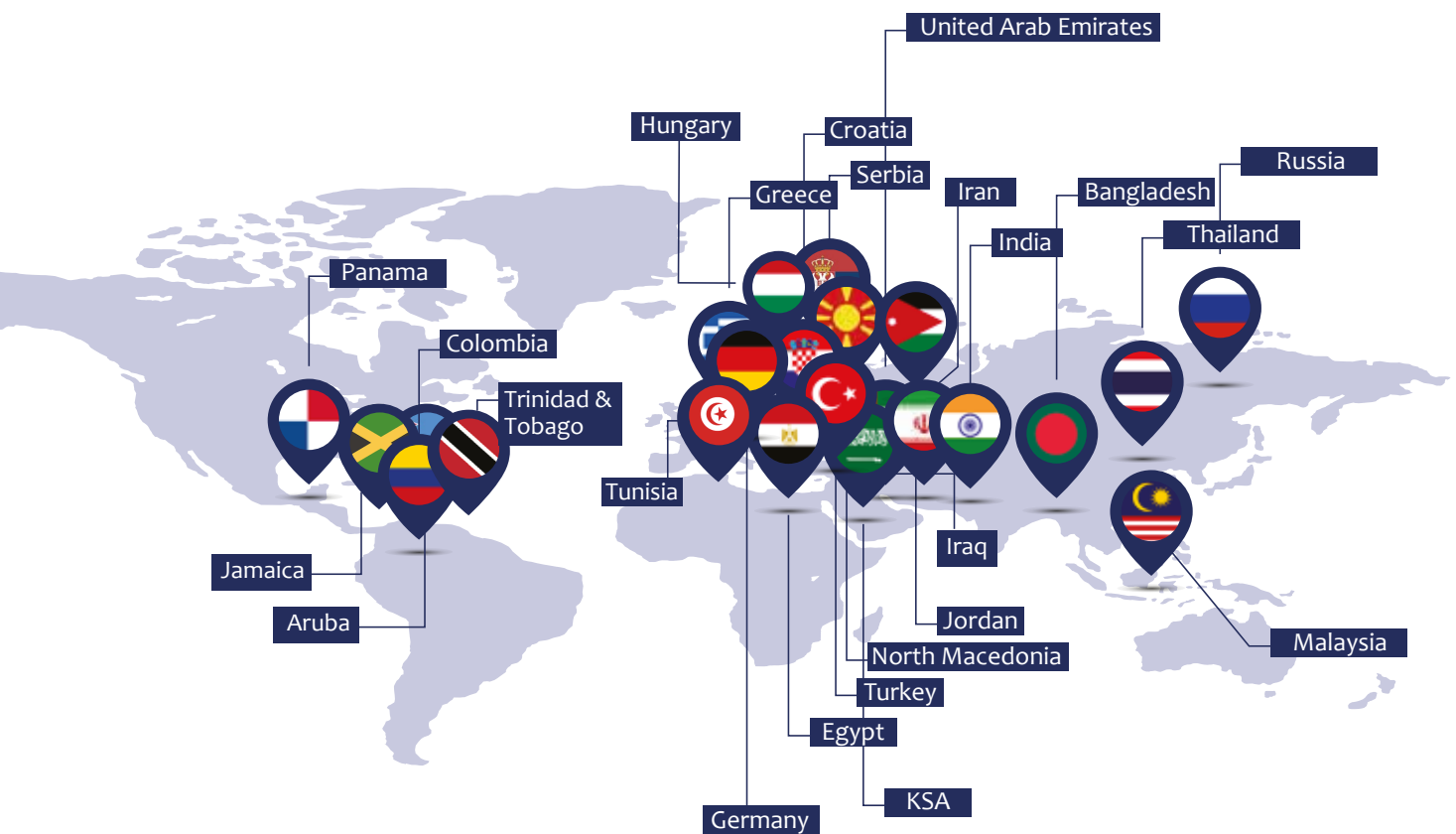
Temos Regional Offices
